With reference to the common Public Notice issued as per decisions of the 333<sup>th</sup> Meeting held on dated 26.03.2021 issued Sri Mahavir Prasad Mahila Mahavidyalaya, incompliance reply is respectfully submitted:-

- 1. That the "Sri Mahavir Prasad Mahila Mahavidyalaya" situated at Surya Nagar, Rajajipuram, Lucknow, Uttar Pradesh is an unaided and self-financed institution, which is established by the Chhatrapati Shahu Ji Maharaj Educational Society, which is a registered society for imparting education in teacher training courses. The aforesaid institution sponsored and run by the above society.
- 2. That it is important to note that the institution-Sri Mahavir Prasad Mahila Mahavidyalaya is an old institution and initially it was granted recognition for conducting B.Ed. basic unit vide Order No. F.NRC/NCTE/F-3/UP-1136/116-124 dated 01.04.2005 with an annual intake of 100 seats w.e.f. 23.05.2005. Thereafter, institution has been granted B.Ed. additional intake vide Order No. F.NRC/NCTE/NRCAPP-2283/2016 meeting/ 54254 dated 13.07.2013 with an annual intake of 100 seats from the academic session 2014-2015.
- 3. That Sri Mahavir Prasad Mahila Mahavidyalaya is a composite institution and is running B.Ed. with 200 intake, B.El.Ed. with 50 intake, D.El.Ed. with 100 intake and M.Ed. with 50 intake. The institution is running above courses in 4930 Sq.Mt. land area at Devpur Road, Rajajipuram, Lucknow in Khasra No. 353, 354, 355, 365 & 382 as per the Building Completion Certificate. The land is in the name of institution i.e. Sri Mahavir Prasad Mahila Mahavidyalaya. The aforesaid

That the Office of Executive Engineer, PWD, Lucknow has issued a certificate vide letter No. 54/M-42/13 dated 01.02.2013 to the effect that the building of the Sri Mahavir Prasad Mahila Mahavidyalaya is constructed as per the National Building Code 2005 NBCC. Moreover, the building is constructed keeping in view the fire safety policy. The office of Chief Fire Officer, Lucknow conducted the building of the institution and issued certificate to this effect vide letter No. 42-/FS/-10 dated 20.02.2020. [Copies of letters by PWD, Lucknow and Office of Chief Fire Officer are enclosed]
- 5. That the institution is affiliated to Lucknow University, Lucknow, which has granted affiliation to the institution for conducting B.Ed. Course with an intake of 100 seats w.e.f. Academic Sessions 2013-14 vide letter No. 14641/Affiliation/2013 dated 10.06.2013. Thereafter, the affiliating University has granted affiliation for additional intake of 100 seats for conducting B.Ed. Course vide Office order No. 11368-88/Aff./2014 dated 22.03.2014. [Copies of Office orders/Letter are enclosed].
- of the National Council for Teacher Education Act (73 of 1933) and in supersession of the National Council of Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014. On promulgation of the NCTE Regulations, 2014 the institution submitted an affidavit and consented to come under New Regulations of 2014 vide letter dated 11.01.2015 with affidavit (Copy enclosed).
- 7. That in pursuance of letter No. NRC/NCTE/UP-1136/NRCA2283/B.Ed./100720-725 dated 20.05.2015, the institution has submitted list of faculties of B.Ed. to the NRC, NCTE vide letter vide Ref. No. SMPMM/4519/16 dated 29.02.2016 which was received by the NRC on 03.03.2016 (Copy Enclosed).


